Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 12:00pm Australian Eastern Daylight Time (AEDT) **on** 25/03/2022.

**By Email:** A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to <u>IEBnominations@aec.gov.au</u>

- 1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
- 2. In order to be able to be received by the AEC, emails should be no greater than 6 MB in size.

## **Withdrawing Nominations**

Nominations cannot be withdrawn after 12:00pm Australian Eastern Daylight Time (AEDT) on 25/03/2022.

## **Candidate Statements**

Candidates may include with their nomination form a statement not exceeding 200 words containing only the candidate's personal history and only the candidate's policy statement to be included with ballot material. Only statements which comply with the Rules and are received by the Returning Officer by 12:00pm Australian Eastern Daylight Time (AEDT) on 25/03/2022 can be accepted.

## **Voting Period**

The ballot, if required, will open on 14/04/2022 and close at 5:00pm Australian Eastern Standard Time (AEST) on 18/05/2022.

#### Scrutineers

The appointment of scrutineers opens 11/03/2022 and closes 5:00pm Australian Eastern Standard Time (AEST) on 19/05/2022. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
